New business:

- **COA application- 618 Chest-Arneytown Road-** Proposed fence with cedar cap trim, Mr. Cardone made a motion seconded by Mr. Codella to approve application as submitted, all in favor, motion carried.
- COA Application- 20 Front Street- Proposed restoration of barn built in 1910. The barn is not visible from the road, but the applicant still wanted to come before the HPC. The applicants have invested \$60,000 into the restoration of the barns foundation to ensure the building wouldn't collapse. They want to replace the siding and windows as well. The applicant plans to use Anderson 400 series to comply with historic guidelines. Mr. Cardone made a motion seconded by Mr. Ratajczak to approve application as submitted.
- **COA Application-14 Church Street** Proposed change from existing slate rood to Timberline shingles to resemble slate roof. Applicant stated it wouldn't be cost effective to repair rather than replace the whole roof. Mr. Cardone made a motion seconded by Mr. Ratajzcak to approve application as submitted, all in favor, motion carried.
- **COA Application- 7 New Street-** Proposed cedar fence to contain horses and prevent dumping and vandalism. Fence will be stained black, Mr. Cardone made a motion seconded by Mr. Ratazcak to approve as submitted, all in favor motion carried.
