**A CAPITAL ORDINANCE OF THE TOWNSHIP OF CHESTERFIELD
AUTHORIZING THE APPROPRIATION OF \$50,000.00 FROM THE CAPITAL
IMPROVEMENT FUND FOR CONSTRUCTION DEPARTMENT VEHICLE**

BE IT ORDAINED by the Township Committee of the Township of Chesterfield as follows:

SECTION 1. There is hereby approved as capital projects within the Township of Chesterfield, not to exceed the costs noted below:

<u>Project / Purpose</u>	<u>Amount Authorized</u>
CONSRUCTION DEPARTMENT VEHICLE	\$ 50,000.00

SECTION 2. There is hereby appropriated from the Chesterfield Township Capital Improvement Fund for the sum of \$50,000.00 to cover the cost of the projects described in Section 1.

SECTION 3. This ordinance shall take effect upon final adoption and publication in accordance with the law.

SECTION 4. The project is included in the capital budget and approved on April 25, 2024 and available for inspection in the office of the Township Clerk.
