APPLICATION FOR ACTION

Anthony Serinese 70 Old York Road, Block 700 Lot 1, Bulk Variance

Anthony Serinese was sworn. He testified that he is seeking a bulk variance to add and addition to the right of his existing garage because he needs more room. He stated that the addition will be 15 x 40 for hobby use only. Mr. Kelly mentioned that the existing structure is already larger than what the ordinance allows even though the addition isn't substantial it is larger than permitted. Mr. Hirsh stated that the existing building lot coverage is 4.04 % the permitted coverage is 4% and the proposed coverage is .06% for a total of 4.6%. The existing evergreens and shrubs as screening will be sufficient. Mr. Serinese stated there is adequate utilities already in the existing garage. There will be an overhead door on the exterior of the addition along with a man door from the exiting to the proposed addition. The overhead door will face Old York Road as does the existing. There is an existing concrete driveway and he would add a concrete pad which will connect to the addition. Mr. Serinese testified there will be no commercial use.

Chairman Kelly opened the meeting for public comment. Hearing none the public portion was closed.
