**RESOLUTION AUTHORIZING EMERGENCY
TEMPORARY APPROPRIATION**

WHEREAS, an emergency condition has arisen in that the Township is expected to enter in contracts, commitments or payments prior to the 2022 budget and no adequate provision has been made in the 2022 temporary budget for the aforesaid purposes, and

WHEREAS, the Township Committee will not consider adoption of the 2022 Municipal Budget prior to the meeting of April 28, 2022, and

WHEREAS, the total emergency temporary appropriation resolutions adopted in the year 2022 pursuant to the provisions of Chapter 96, P.L. 1951 (N.J.S.A. 40A:4-20) including this resolution total \$ 2,233,100.00 for the Municipal Budget and \$179,325.00 for the Sewer Utility Budget

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Chesterfield in the County of Burlington and State of New Jersey, that in accordance with the provisions of N.J.S.A. 40A:4-20:

1. Emergency temporary appropriations be and the same are hereby made in the amount of \$2,233,100.00 for the Municipal Budget and \$179,325.00 for the Sewer Utility Budget as follows:
