**RESOLUTION ESTABLISHING MEETING DATES OF THE  
TOWNSHIP COMMITTEE FOR THE YEAR 2023**

**BE IT RESOLVED** by the Township Committee of the Township of Chesterfield in the County of Burlington and State of New Jersey that during the year 2023 the regular meetings of the Chesterfield Township Committee will be held the second and/or fourth Thursdays of each month, unless otherwise indicated, at the hour of 6:30 PM beginning with Closed/Executive Session, if needed, with the Regular Township Committee beginning at 7:00 PM. Meetings will be held at the Municipal Building, 295 Bordentown-Chesterfield Road in Chesterfield Township. Formal action may be taken on any matters within the purview of the Committee and any meeting may be cancelled if found to be unnecessary. Such cancellation shall be posted/noticed on the Township’s website once the decision has been made. The Township Committee reserves the right to cancel either or both the Closed/Executive Session and/or on the Regular meeting, as circumstances dictate. The Regular meetings will also include the Chesterfield Township Board of Health, as business necessitates. The Regular meetings will also allow public participation by electronic means to the extent permitted by GoToMeeting technology (in other words, a “hybrid” meeting conducted live/in-person, but also viewable virtually). Members of the public can attend at GoToMeeting.com by clicking on the “join” tab at the top and entering the Meeting ID number 528-823-501. Access through telephone is also available by dialing the telephone access number 1-872-240-3412 and entering the Meeting ID number when prompted. However, because of the uncertain reliability of a virtual platform to facilitate interactive communication during such a hybrid meeting, members of the public wishing to speak to the Township Committee are encouraged to be present at the municipal building instead of participating remotely.
