RESOLUTION AUTHORIZING CHANGE ORDER #1 FOR SYKESVILLE ROAD PHASE IV & V IMPROVEMENT PROJECT AWARDED TO PAVING PLUS LLC

WHEREAS, the Township of Chesterfield awarded a contract to Paving Plus LLC for the Sykesville Road Phase IV & IV Improvement Project in the amount of \$324,603.00; and

WHEREAS, the Contractor has submitted change order #1 for an increase of \$30,975.00 to reflect the an expansion of the contract to include improvements at Cebulka Drive and Stelle Road and Uniform Traffic Control in the amount of \$13,280.00 which results in an increase of \$44,255.00, a 13.63% increase from the original contract price; and

WHEREAS, the Project Engineer has reviewed and recommends approval of Change Order #1 as outlined in that attached letter dated December 12, 2023 attached hereto and made part of this resolution; and

WHEREAS, the Finance Officer has certified that funds are available for this change order updating the contract amount to \$368,858.00.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Chesterfield Change Order #1 is approved and consequently amends the contract with Paving Plus LLC to a revised contract amount of \$368,858.00.

Enclosed with this letter, please find the following:

- 1. Three (3) Copies of Change Order No. 1 for Phase IV Improvements.
- 2. Three (3) Copies of Change Order No. 1 for Phase V Improvements.

As you know, construction on the above referenced contract is ongoing and is funded with two (2) NJDOT Municipal Aid grants.

The Township has requested that the contract be expanded to include improvements at Cebulka Drive and Stelle Road which was summarized in a letter to you dated November 30, 2023, attached. These improvements increase the contract by \$30,975.00.

Additionally, the change order includes a supplemental pay item for Uniform Traffic Directors. This cost was not included in the bid documents per prior reviews with Township representatives and consistent with the Sykesville Improvements Phase IV bid documents prepared by the prior Township Engineer. The cost associated with Uniform Traffic Directors is \$13,280.00.

Because the contract is funded with two (2) NJDOT grants, change orders must be prepared for both funding sources. As the bid amounts for each phase are less than the NJDOT grants received as well as the initial Engineer's Estimates, the Township has an opportunity to split the above costs between the two phases to maximize the available budgets.

The NJDOT grant for Phase IV has approximately \$69,000 of unused funds available. The NJDOT grant for Phase V has approximately \$9,000 of unused funds available.

The above change orders increase the overall contract by 13.63%.
