**RESOLUTION AUTHORIZING THE PURCHASE OF GOODS OR SERVICES
THROUGH STATE OF NEW JERSEY CONTRACTS AND COOPERATIVE
PURCHASING AND PRICING AGREEMENTS**

WHEREAS, the Township of Chesterfield has the need to purchase various goods or services in the year 2024; and

WHEREAS, it is anticipated that some goods or services will be exceeding the bidding threshold of \$44,000.00, as established in the Local Public Contracts Law by commodity, in the aggregate; and

WHEREAS, all State Contracts and Cooperative Purchasing & Pricing Agreements awards have been publicly bid; and

WHEREAS, pursuant to the provisions of N.J.S.A. 40A:11-12 municipalities are permitted the use of awarded New Jersey State Contracts; and

WHEREAS, pursuant to the provisions of N.J.S.A. 52:34-6.2 municipalities are permitted to enter into Cooperative Purchasing Agreements, permitting the use of those awarded contacts; and

WHEREAS, pursuant to the provisions of N.J.S.A. 40A:11-10 and N.J.A.C. 5:34-7.11 municipalities are permitted to enter into Cooperative Pricing Agreements, permitting the use of those awarded contacts; and

WHEREAS, the Township of Chesterfield has previously approved membership in the following Cooperative Purchasing & Pricing Agreements and desires to continued use in 2024:
