**RESOLUTION OF THE TOWNSHIP OF CHESTERFIELD
APPOINTING HAILEY BELL AS MUNICIPAL ALLIANCE COORDINATOR**

WHEREAS, The Governor’s Council on Alcoholism and Drug Abuse was established by the New Jersey legislature in March of 1989 to coordinate all State Departments efforts pertaining to the planning and provision of prevention, education, treatment, research, and evaluation services for, and public awareness of, alcoholism and drug abuse; and

WHEREAS, the legislation also created the Alliance to Prevent Alcoholism and Drug Abuse to be comprised of all the communities in New Jersey dedicated to a comprehensive and coordinated effort against alcoholism and drug abuse through the use of funds provided and derived pursuant to N.J.S.A. 2C:35-15, to member communities to support appropriate county and/or municipal based alcohol and drug abuse education and public awareness activities; and

WHEREAS, the Chesterfield Township Municipal Alliance Coordinators in conjunction with the members of the Chesterfield Township Alliance Against Substance Abuse Committee have requested the Mayor and Township Committee approve the appointment of the Municipal Alliance Coordinators to assist and coordinate efforts pertaining to the planning and provision of prevention, education, treatment, research and evaluation services for (and public awareness of) alcoholism and drug abuse; and

WHEREAS, Adelaide Napoleon has been the Municipal Alliance Coordinator since 2022 and resigned effective March 31, 2024; and

WHEREAS, Hailey Bell has indicated an interest in fulfilling the position of Municipal Alliance Coordinator vacated by Ms. Napoleon; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Chesterfield that Hailey Bell is hereby appointed the Municipal Alliance Coordinator effective April 1, 2024; and

BE IT FURTHER RESOLVED that payment for services provided by the appointee shall be made from the funds received through the Municipal Alliance Grant and Trust dedicated to Municipal Alliance purposes and shall not exceed the terms of the grant; and
