### May 9, 2019

The Township Committee met on the above date with Mayor Romeu calling the meeting to order at 7:00 PM. The meeting opened with the flag salute and a moment of silence. ### **CONSENT AGENDA**

Mr. Liedtka made a motion seconded by Ms. Katz to approve the minutes from April 25, 2019. All were in favor.

Mayor Romeu made a motion seconded by Mr. Liedtka to table the Public Safety Report until the next meeting. All were in favor.

### **BOARD OF HEALTH**

Block 302 Lot 7.02 – 376 Crosswicks-Ellisdale Roade – Septic Waiver – Homa

Mr. Hirsh reported that an application for this property has been received for the construction of a septic system to replace an existing septic system.

Mr. Hirsh reported that the septic field location appears to be a compromised location to meet building setback, property line setback and maximize, to the extent possible, distance to water course/side year property line. We recommend approval of this variance an reliance on the County Health Department to determine if the proposed 23

feet setback is sufficient by way of condition.

There does not appear to be many options on this site due to the site being oddly shaped and having to situate the septic field between an existing driveways, a side property line and maintain 25 foot separation from the structure.

The seasonal high water table appears to be at a depth of 24 feet below existing per the submitted soil boring information. The disposal field section submitted indicates the field is designed to be a mound, with the finished grade +/- 3.5 feet above the existing grade. The proposed mounding is required to allow for the 4 foot treatment zone above the seasonal high water table. An alternate design is not available to provide the appropriate treatment in this situation, therefore approval of the variance is recommended.

Mr. Liedtka made a motion seconded by Ms. Katz to approve. All were in favor.

With no further comments Mr. Liedtka made a motion seconded by Ms. Katz to close Board of Health. All were in favor.

The Township Committee asked Ms. Hoyer to send the Hoffman's a letter letting them know what they are allowed to do regarding their home expansion and require them to bring in a conceptional drawing detailing exactly what will be in the

addition (bathrooms, bedrooms, etc.) This will then need to go before the Township Committee for approval prior to moving forward.

<u>Chesterfield Fire House</u> – Mr. Liedtka said that the Chesterfield Fire House is asking if money that was promised to them last year to repave their parking lot is still available. Mr. Liedtka updated the Committee telling them that last year the Committee agreed to pay for half of the price to repave the Fire House parking lot with money from the Recreation Fund. This was agreed based on that their parking lot is used to access the recreation fields, tennis courts, walking path and volleyball courts. Mr. Wilson suggested that we find the resolution or documentation regarding this and send it to the Township Committee for their review in order to move forward.

Agreement is memorialized in a "Settlement Agreement and Release" which document is attached hereto and made a part hereof; and

WHEREAS, the Township Committee deems it appropriate to authorize the execution of said Settlement Agreement by the Township Attorney.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Chesterfield, State of New Jersey that the Township Attorney be and is hereby authorized and directed to execute the attached "Settlement Agreement and Release" with K. Hovnanian at Chesterfield, LLC.

#### SETTLEMENT AGREEMENT AND RELEASE

THIS SETTLEMENT AGREEMENT AND RELEASE (the "Agreement") is made effective as of \_\_\_\_, 2019 ("Effective Date"), by and between K. HOVNANIAN AT CHESTERFIELD, LLC, which has a place of business located at 110 Fieldcrest Avenue, Edison, Middlesex County, New Jersey, and CHESTERFIELD TOWNSHIP ("Chesterfield"), a body corporate and politic located in Burlington County, State of New Jersey.

#### WITNESSETH

WHEREAS, K. HOVNANIAN AT CHESTERFIELD, LLC ("Hovnanian") is the developer of property identified as Phases IV, V and VI of Heritage of Old York Village located in the Township of Chesterfield, Burlington County, New Jersey (hereafter, this development is referred to as "Heritage").

WHEREAS, on April 16, 2018, Hovnanian filed an action against Chesterfield captioned: <u>K. Hovnanian at Chesterfield, LLC v. Chesterfield Township</u>, Superior Court of New Jersey, Law Division, Burlington County, Docket No.: BUR-L-000783-18 (the "Action");

WHEREAS, on or about May 23, 2018, Chesterfield filed an Answer and Counterclaim in the Action;

WHEREAS, the Action involves Hovnanian's claims for, <u>inter alia</u>, the release/return of performance guarantees, including Bond Nos. 0111967 and 0111968 and associated cash deposits, as same relates to bonded site improvements for Phases IV and VI of Heritage (the "Performance Guarantees"), along with all escrow funds relating to Heritage;

WHEREAS, the Performance Guarantees for Heritage, which are the subject to this settlement are as follows:
