Mr. Dhopte stated that in the past, the Police would ask the residents to remove their basketball hoops and cars that were in the streets prior to the snow storms in order for the plows to get by. He suggests that the police do this going forward.

Mayor Liedtka thanked Andy Hoyer for helping with the plowing since the Public Works a man short.

Electronic Recycling – Mr. Sahol reported that the electronic recycling has begun at our Recycling Center and is doing very well. There was a lot of recycling after the holidays. The staff is doing a good job and the public is being mindful.
