December 16, 2020

The Township Committee met on the above date via Gotomeeting.com with Mayor Liedtka calling the meeting to order at 10:00 AM. Roll call was taken showing present: Mayor Jeremy Liedtka, Deputy Mayor Lido Panfili and Committeewoman Denise Koetas-Dale. Also present Thomas Sahol, Township Administrator and Caryn Hoyer, Township Clerk. Absent was Committeemen Shreekant Dhopte and Michael Russo.

The Open Public Meetings Act statement was read and compliance noted. The statement on public comment during remote meetings was read.

Mayor Liedtka asked Mr. Sahol to give the Township Committee some background on the CDBG project. Mr. Sahol explained the grant is administered through Burlington County and associated with low income or ADA compatibility. We have no areas that would qualify under the income category however we are eligible for accessibility improvements. The grants are generally \$60,000 - \$75,000 and we know the cost to complete all the accessibility improvements identified as part of this grant will likely exceed the typical grant amount. However, a survey has been completed of all the handicap ramps in the community and we have prioritized 40 of those ramps for this application in hopes that a favorable bid will allow us to complete this group as a first phase of a multi-year approach to address issues with ramps.

PUBLIC HEARING FOR COMMUNITY DEVELOPMENT BLOCK GRANT PROJECT ADA COMPLIANCE IMPROVEMENTS

Ms. Koetas-Dale made a motion seconded by Mr. Panfili to open the public hearing and accept public comment. All were in favor.
