#### RESOLUTION RECOGNIZING ARBOR DAY CELEBRATION

**WHEREAS**, the Legislature of the State of New Jersey has adopted an Act designating Arbor Day; and

**WHEREAS,** it is the purpose of the designation of this day throughout the nation to encourage the planting of shade and forest trees, to encourage the harvesting of our forest crops by approved conservation methods, and to encourage the protection of our forests from the scourge of devastating fires,

insects and diseases that destroy the beauty and usefulness of our woodlands as well as their wildlife; and

**WHEREAS,** through the cooperation of all residents of this community, the beneficial effects of forest tree plantings, proper conservation practices in harvesting timber, and the protection of the forest from natural enemies can be materially increased, and we can pass on an enduring heritage of a vital natural resource to succeeding generations.

**WHEREAS**, a White Oak was donated by Chesterfield Gardens and planted at the municipal complex by the Department of Public Works.

### A RESOLUTION REQUESTING PERMISSION FOR THE DEDICATION BY RIDER FOR TDR CREDITS - TURNPIKE TRUST FUND

**WHEREAS**, permission is required of the Director of the Division of Local Government Services for approval as a dedication by rider of revenues received by a municipality when the revenue is not subject to reasonably accurate estimates in advance; and

WHEREAS, the Township entered into an agreement with the New Jersey Turnpike Authority and the State of New Jersey, Department of Environmental Protection where the NJ Turnpike Authority paid monies representing consideration for the extinguishment of Transfer of Development Rights Credits due to the widening of the Turnpike, and

**WHEREAS**, the Township agreed to utilize said monies specifically to "bank" these funds to be utilized for the purchase of TDR Credits when needed, and

**WHEREAS**, N.J.S.A. 40A:4-39 provides the dedicated revenues anticipated for TDR Credits - Turnpike are hereby authorized as revenue and are hereby appropriated for the purpose to which said revenue is dedicated by statute or other legal requirement.

**NOW, THEREFORE, BE IT RESOLVED**, by the Governing Body of the Township of Chesterfield, County Burlington, State of New Jersey, as follows:

### **REPORTS & DISCUSSIONS**

Mr. Hirsh stated the contractor is finishing up repair work on Sykesville Road today and tomorrow and doing alternate work on Ellisdale and Extonville Road. Traditions is paving as well. Mr. Hirsh stated concrete was poured at the Fenton Lane restrooms today and should be completed in the next week or so. Mayor Liedtka asked if we can put a snow fence up while they are still working so we can open up the building. Mayor Liedtka asked Recreation Director Rachel Fryc to put a memo out to see if anyone is interested in renting the building. Ms. Fryc agreed to do so and will work with Mr. Sahol to put COVID precautions in place prior to renting out the building and anyone wanting to rent the building will be aware and can determine if they want to use the building or not.

Mr. Sahol reported that the Township Plant Give-Away that occurred on April 1<sup>st</sup> was a huge success. He stated that in 3 hours the Township gave away over 7,000 pots. Mr. Sahol thanked the staff that participated.

Mr. Sahol advised the committee he is working with Sherri Dudas from the Green Team and Ms. Koetas-Dale to submit a grant for a community compost project. If successful, we would purchase about 180 compost bins and they would be distributed on a first-come first-serve basis. The Township will be providing in kind match. We should have a resolution by May to authorize the grant submittal. Ms. Koetas-Dale thanked Sherri Dudas for writing the majority of the grant and said that the grant will be \$10,000.

Mr. Sahol stated the Public Works Department is working hard to get the volleyball court completed. They have been hindered by the weather. They should be completed in the next week.

Ms. Koetas-Dale reported the first Shade Tree Commission meeting was held. Troy Ulshafer is the Chair, Larry Kuser is the Vice-Chair and Elise Bremer-Nei is the Secretary.

Ms. Koetas-Dale made a motion seconded by Mr. Panfili to open the meeting to public comment. All were in favor.

Agnus Marsala - 42 Cromwell Drive asked the Township Committee if they were aware that there were three IR's not just the one at 31 Bordentown-Chesterfield Road. She asked who is monitoring them while in our town. She is sure they are getting away with things. Mayor Liedtka said that the County is supposed to have an inspector. He said we only knew about the one IR. The DEP should have been notified. Mr. Sahol said that he will get the information on the IR's and report back to the Township Committee. He also stated the County inspector was on site with the IR in roadway that spilled onto the homeowners' property within the County right-of-way.

Hearing no further comments Mr. Dhopte made a motion seconded by Mr. Russo to close public comment. All were in favor.

Mayor Liedtka said that we have reason to go into Executive Session tonight under Attorney Client Privilege. No action will be taken.
