Mr. Liedtka made a motion seconded by Mr. Russo to approve the bill list. Voice vote – All Ayes

REPORTS & DISCUSSION

Engineering Report – Mr. Hirsh reported the following:

- -White Pine Road will go to DOT by Monday for approval to bid.
- -The handicap ramp will go to CBGB for their approval to bid early next week.
- -The elimination of the wooden path at Charlotte Rogers walking path is scheduled for tomorrow.

Mayor Panfili asked about the bridge on Sykesville Road and how long it will take for the County to repair it. Mr. Liedtka stated he spoke with the County and was informed it will take 6-8 weeks to repair once the consultant is hired. He also stated the County contact the Township as soon as the plans are final for Main Street for our review.

Mayor Panfili asked Mr. Hirsh if he has been in touch with the contractor regarding additional punch list work on Sykesville Road. Mr. Hirsh replied yes and he is waiting for the schedule.

Pickle Ball – Mr. Hirsh stated the he met with Troy and Belinda to look at a few locations for the pickle ball courts and Fenton Lane is the best location. Mr. Hirsh supplied the Committee with two different layouts of the courts for their review. Mr. Hirsh said the estimated cost is \$50,000.00 for the two courts. He recommended the side by side courts next to the tennis courts and closer to the walking path and parking lot. The Township Committee agreed on that layout. The Committee will introduce a capital ordinance from the recreation fund at the March 24th meeting.

DPW/RECREATION

Mayor Panfili asked Troy and Rachel about ordering the baseball tarps. Troy replied he and Rachel are looking into what to order. Mayor Panfili asked Rachel if she ordered the indoor pickle ball equipment. Ms. Blazic replied that she does not want to order it at this time.

NEW BUSINESS

Routes 677 & 660 alignment and curvature easing safety - Ms. Koetas-Dale would like to approach the County about straightening Chesterfield-Crosswicks Road for safety purposes. She would also like to suggest lowering the speed limit and enforcing it. Mayor Panfili agrees. Mr. Gillespie asked if this would affect the ROSI area of the development. Ms. Hoyer disagrees with straightening of the road and feels it will cause more speeding. She stated only a round- a-bout would work. Mr. Sahol will ask the County Engineers if they have any suggestions. Mayor Panfili asked to get a traffic study from the County of that section of the road. Mr. Sahol said that he and Mr. Hirsh will sit down with the County with all of the Committee's questions and concerns.

PUBLIC COMMENT

Mr. Liedtka made a motion seconded by Ms. Koetas-Dale to open the meeting to the public. All were in favor.

Dawn Donahue, 79 Bordentown-Chesterfield Road thanked the Township Committee and the Police Department for catching the people that were breaking into cars in town. She

also thanked Mr. Sahol and Troy for taking her calls. She said residents are not picking up after their dogs in the development.

Herb Ames, 106 Chesterfield-Crosswicks Road asked if the Township Committee has sat down with the County and if they are planning on doing anything on Chesterfield-Crosswicks Road. Mayor Panfili replied that the County Engineer reported that there is no funding for the round-a-bout. Mr. Ames asked if we can go to the County Commissioners. Mr. Ames said that intersection is very dangerous and we need a round-a-bout.

Shreekant Dhopte, 18 Donlonton Circle thanked the Committee for the update on the pickle ball court. He asked how much it will cost to put in the new pickle ball court. Mr. Hirsh replied \$48,000.00 for option A and \$47,000.00 for option B if DPW does not do the grating. Mr. Dhopte asked about the tennis wall. He said the tennis wall was high on the Recreation Survey list and asked if we are still considering it. Mayor replied yes we will go out to bid again and plan to put it at the Municipal Park if approved. Mr. Dhopte asked about the boat ramp that was also proposed based on the Recreation Survey. Ms. Koetas-Dale replied there were some wet land issues and not a lot of requests from residents since the survey.

Vibhor Batra, 5 Saddle Way thanked the Committee for the new pickle ball court. He would like a tennis wall as well.

Ms. Koetas-Dale thanked the Budget Advisory Committee.

Mr. Liedtka made a motion seconded by Ms. Koetas-Dale to close public comment. All were in favor.

A motion to adjourn the meeting was made Mr. Liedtka and seconded by Ms. Blazic. All were in favor. Meeting Adjourned at 7:34 PM.
